The BAC will conduct the procurement process in accordance with the Revised IRR of R.A. 9184. Bids in excess of the ABC shall be automatically rejected at the opening of bid. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/ fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

To bid for this Contract, a contractor must submit a Letter of Intent (LOI), purchase bid documents and must meet the following major criteria: (a.) Duly licensed Filipino citizens/sole proprietorship (b.) Filipino citizen owned partnership, corporation and cooperatives with at least seventy five

percent (75%) of the interest or outstanding capital stock belongs to citizens of the Philippines (c.) with PCAB license applicable to type and cost of this contract (d.) Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid, except under conditions provided for in Section 23.4.1.3 and 23.4.2.4 of this IRR, within the relevant period as provided in the Bidding Documents. Bidders may obtain further information from the City Government of Tanauan and inspect the Bidding documents at the address given below during 8:00 am to 5:00pm.

A complete set of bidding documents may be purchased on July 30,2021 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount based on the amount of project cost.

The Pre-Bid Conference is on 2:00pm/August 6,2021 at BAC Conference Room. Bids must be delivered to the address below on August 18,2021 on or before 10:00 a.m. All bids must be accompanied by a bid security in any of acceptable forms. Late bids shall not be accepted. Bids will be opened in the presence of the Bidder's representative with Special Power of Attorney (SPA) who chooses to attend at the address below on 10:00am/ August 18, 2021 at Bids and Awards Committee (BAC) Conference Room.

The City Government of Tanauan reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
