2) The City Government of Tanauan now invites bids for supply and delivery of 40" LED TV of the prospective bidder of all its ongoing and completed government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, within the relevant period. All bids must be accompanied by a bid security in any of acceptable forms in the amount.
