AN ORDINANCE INSTITUTIONALIZING THE MONTH OF MARCH AS WOMEN'S MONTH SPORTS FESTIVAL IN THE CITY OF TANAUAN

WHEREAS, in his first State of the Nation Address (SONA), President Rodrigo Roa Duterte directed "all agencies, oversight bodies and local government units down to the barangay level to fully implement the Magna Carta of Women, and to ensure that man and woman will be partners in the country's economic, social, cultural and political developments;

WHEREAS, it is declared in Proclamation No. 224 that the first week of March of every year as Women's week and March 8, 1988 and every year thereafter as Women's Rights and International Peace Day;

WHEREAS, it is appropriate to declare the month of March every year for the observance of "Women's Sports Festival" in the City of Tanauan- in solidarity with the Women's Month Celebration, and in commemoration of the vital role of women in nation building;

NOW, THEREFORE, upon the recommendation of the Committee on Women and Family and by a unanimous vote of all the Members present, BE IT ENACTED by the Sangguniang Panlungsod of the City of Tanauan, that:

Section 1. Title. This ordinance shall be known as the: "AN ORDINANCE INSTITUTIONALIZING THE MONTH OF MARCH AS WOMEN'S SPORTS FESTIVAL IN THE CITY OF TANAUAN".

Section 2. Declaration of Policy. RA 9710- The Magna Carta of Women. The State shall provide the necessary mechanisms to enforce women's rights and adopt and undertake all legal measures necessary to foster and promote the equal opportunity for women to participate in and contribute to the development of the political, economic, social, and cultural realms. The State, in ensuring the full integration of women's concerns in the mainstream of development, shall provide ample opportunities to enhance and develop their skills, acquire productive employment and contribute to their families and communities to the fullest of their capabilities.

Section 3. Definition of Terms.

- **Badminton-** is a woman racquet sport played using racquets to hit a shuttlecock across a net. The game shall be "singles and "doubles" with players per side.
- b. Basketball- is a woman limited-contact team sport, which is played three-on-three on a half court.
- c. Cheering Competition- is a woman group competition, showing athletic skills, jumps, dance and/or chanting.
- **d. Fun Run-** a friendly race amongst women that involves road *running* with participants taking part for their own enjoyment rather than competition.
- e. Swimming- is an individual or women team sport that requires the use of ones arms and legs to move the body through water.
- f. Tug of War- a contest in which two teams of women pull at opposite ends of a rope until one drags the other over a central line.
- g. Volleyball- is a woman team sport in which two teams of six players are separated by a net. This will be one of the official programs in woman sports festival.

Section 4. Women Sports Festival

- A month long tailor made sports activities or sport competitions amongst women organizations in the City of Tanauan.
- A sports festival that is mandatory included in celebration of Women's Month, month of March every year;

 An activity that is intended to engage and provide healthy competition between Women Organizations in the City of Tanauan and to use sport as a means to develop social interaction, rapport and camaraderie.

Section 5. Implementation.

- a. The City Sports Development Office, City Social Worker and Development Office (CSWD) together with Gender and Development Office (GAD) are mandated to execute the provisions of this ordinance.
- b. Preparation of program shall be a shared responsibility of the City Sports Development Office and Gender and Development Office (GAD). Gender and Development Office (GAD) shall be the lead or primary responsible office in program and activity preparation.
- c. The activities that shall be mandatory included in Women Sports Festival are badminton, basketball, swimming, volleyball, cheering competition, fun run and tug of war.

Section 6. Funding. The City of Tanauan shall allocate an annual funding of Five Hundred Thousand Pesos (Php 500,000.00) in the Gender and Development Office (GAD) for the strict implementation of this ordinance.

Section 7. Repealing Clause. All other provisions of existing ordinances, resolutions and executive issuances inconsistent with this ordinance are hereby repealed, amended or modified accordingly.

Section 8. Declaration of Intent to Conform to Law. This Ordinance is subject to national laws, rules and regulations governing its subject matter.

Section 9. Effectivity Clause. This ordinance shall take effect upon the approval.

ENACTED this 9th day of July 2018 at the City of Tanauan.
