

KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT FOR THE SUPPLY & DELIVERY OF EMERGENCY ALERT AND DISPATCH SYSTEM IN THE CITY OF TANAUAN, PROVINCE OF BATANGAS**, made and executed this 12th day of March 2021 in the City of Tanauan, Province of Batangas, Philippines, by and between:

The **CITY GOVERNMENT OF TANAUAN**, a local government unit in the Province of Batangas, created and existing pursuant to law with office address at New City Hall Building, Laurel Hill, Barangay Natatas, City of Tanauan represented herein by the City Mayor **HON. MARY ANGELINE HALILI** and herein referred to as the **“PROCRURING ENTITY”**

-and-

TWIS TRADING, a sole proprietor and existing pursuant to law with office address at 257 Barangay Sala, City of Cabuyao, Laguna and extension office at 23 Bella Subdivision Rosas St. Barangay Sala, City of Cabuyao, Laguna represented by its owner **MARINA A. SALCEDO** and herein referred to as the **“SUPPLIER”**

WITNESSETH that:

WHEREAS, the **FIRST PARTY** is in need of competent entity who could meet its requirement for the **SUPPLY & DELIVERY OF EMERGENCY ALERT AND DISPATCH SYSTEM IN THE CITY OF TANAUAN, PROVINCE OF BATANGAS;**

WHEREAS, in accordance with Republic Act 9184 and its Revised Implementing Rules and Regulations, it was determined that the Supplier submitted the proposal for the procurement of the Goods at a contract price of Twenty-Seven Million Nine Hundred Two Thousand One Pesos only (₱27,902,000.00) during the bidding held last January 15,2021;

WHEREAS, upon post qualification and careful examination, validation and verification of all eligibility, technical and financial requirements submitted by the bidder, the bid proposal of the **SUPPLIER** was found to be responsive;

WHEREAS, the **PROCRURING ENTITY** has issued a Notice of Award to the **SUPPLIER**, and the Supplier has signified its conformity to the award last January 29,2021 and notice to Proceed;

NOW THEREFORE, for and in consideration of the foregoing premises and in accordance with the stipulations herein set forth, the parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. **Duration and Services.** The Contract for the Supply & Delivery of Emergency Alert and Dispatch System in the City of Tanauan, Province of Batangas shall be valid and binding for a period of one hundred twenty days (120days).
3. **Scope and Costing.** The **SUPPLIER** undertakes to Supply & Delivery of Emergency Alert and Dispatch System in the City of Tanauan, Province of Batangas in accordance to the specifications stater in the attachment **“ANNEX A”**.
