5) A complete set of Bidding documents may be purchased by interested bidders on September 21, 2022 from the address below and upon payment of a nonrefundable fee amounting to Five Thousand Pesos (5,000.00) for the Bidding Documents in the amount based on the amount of project cost.

6) The Pre-bid conference is on 11:00 A.M September 28, 2022, at BAC Conference Room.

7) Bids must be delivered to the address below on or before 10:00 A.M, October 10, 2022. All bids must be accompanied by a bid security in any of acceptable forms in the amount.

A) Form of Security Minimum Amount in % of Approved Budget for the Contract to be Bid.

1)Cash, certified check, cashier's check, bank draft or irrevocable letter of credit. Two percent (2%) 2)Bank Guarantee two percent (2%) 3)Surety Bond five percent (5%)

Bid opening shall be on 10:00 A.M October 10,2022 at BAC Conference Room. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

8) Pursuant to GPPB Circular 06-2005, in case the bid resulted into a tie and after determining the Lowest Calculated and Responsive Bidder (LCRB), Highest Rated Responsive Bid (HRRB), Bid Evaluation and Post-qualification the BAC Members will convene and determine the winning bidder using the "Draw Lots" method.

9) The City Government of Tanauan reserved the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
